

DECLARATIONS OF ELECTION AND NOTICE OF BALLOT ACADEMIC STAFF MEMBERS OF THE ACADEMIC BOARD 2026-2027

1. Close of Nominations

The Call for Nominations for the following academic staff members of the Academic Board for the 1 January 2026 – 31 December 2027 term of office is now closed.

In circumstances where there are an equal number to or fewer nominations than positions available, the candidates are to be declared elected, as detailed in **Attachment 1**.

Where there are more candidates than the number of positions, a ballot will be conducted, as detailed in **Attachment 2**.

2. Voting and Eligibility

Academic staff members from the specific electorates noted in Attachment 2 are eligible to vote in the elections for academic staff representatives on the Academic Board. Eligible staff will be directly invited to vote by the Governance Directorate and voting will take place using the BigPulse online voting system, according to the timeline detailed in Item 3 below.
