Ms Jane Allnutt RN RM Dip Teach(Nursing) BSc MPH PhD Candidate Thesis Title: Exploring the Nurse Practitioner service in New South Wales

Health-care reforms in Australia have enabled the establishment of Nurse Practitioner Services (NPS), creating an additional clinical position and career pathway for nurses. This qualitative study investigates the evolvement of three NPS in New South Wales. This study asks how the NPS evolved and its interface with the existing health service; clinicians' experiences and opinions on the interface of the NPS with existing health services; and patients' and/or parents' experiences with the NPS. An intrinsic case study method was used to collect data from field observations, interviews, and a retrospective medical record audit. This research explores this innovative service model and seeks to understand it both from professional and patient perspectives. The NPS in NSW remains relatively new and research is needed to ensure the efficacy and sustainability of this service model.

Thesis Title: Evaluation of a day-time drop-in support centre for women who are homeless or at risk of homelessness

Services are available for people who are at risk of being, or who are homeless, many of which have not been evaluated. This project identifies and describes i) a housing support program and ii) a daytime drop-in support centre, both aimed at people at risk of being or who are homeless. In particular, it identifies and describes a housing support program from the perspectives of the clients, the case managers, and people who referred clients to the program as well as the perspectives of the clients, the case managers, service providers, and volunteers at the maintenance support centre.

ACU Nursing Student and Undergraduate Research Intern Project undertaken: Systematic review to identify the barriers and enablers for a triage, treatment, and transfer intervention in acute stroke care

As a Clinical Nurse Consultant, research is one of the main domains for my professional portfolio. I have worked at St Vincent's Hospital Sydney (SVHS) since 2012 and had not previously been involved in research as it had always frightened me. My clinical role is primarily that of wound management and has been for over 10 years. Associate Professor Elizabeth McInnes, Deputy Director of the NRI, is a member of SVHS's Wound Care Committee. Through her encouragement and ability to make it seem not so daunting, I become part of the clinical aspect of research two years ago. I first joined the NRI to complete stage two of a multi-site research project, the INTroducing A Care bundle To prevent pressure injury (INTACT) trial. This was invaluable as I was encouraged and invited to ask as many questions as needed. Each section of the project was calmly and carefully set out and explained. I learnt that it's a team that is needed to start compiling the right questions. With an air of confidence I then decided to take on the role of lead investigator for an incidence study on the Surgical Patient Pressure Injury Incidence (SPPII) study. This study is still running and it has been great to find myself able to answer queries and questions for others interested in research.

Project: What are the barriers and enablers to using whiteboards in an acute hospital setting? A mixed-methods study Hospital: Mater Hospital Sydney Position: Registered Nurse



I am a registered nurse who has worked in both the public and private health systems for 20 years. For the last 10 years my primary interest has been cardiac nursing. I came to be involved with the NRI after seeing a flyer calling for expressions of interest in a seconded mentored research position. My interest was immediately piqued, as the opportunity to perform mentored research was very appealing. Having Dr Cintia Martinez-Garduno, an NRI Research Assistant, there to guide me through the steps and give me hints as to what I should prioritise was priceless. The project 'What are the barriers and enablers to using whiteboards in an acute hospital setting? A mixed-methods study' appealed as I was new to my then hospital ward at the time of the introduction of whiteboards. Walking into the NRI on the first day I had no idea what to expect, but was immediately put at ease, as all the staff were very warm and welcoming. I knew I would be doing literature reviews, and planning and designing the research method, but the experience also involved much more, from designing posters and flyers, organising transcripts, catering for focus groups, as well as the opportunity of attending training days for things like NVivo computer programmes. I now feel I have the tools to put my hand up at work should some research be required, and am weighing up the possibility of applying for a research degree.

Project: Implementation of a patient blood management program in an Australian private hospital orthopedic unit: A pilot study Hospital: Mater Hospital Sydney Position: Clinical Data Analyst

After many years of nursing and clinical teaching, in 2008 I joined the Mater Quality Improvement Unit and my current position is that of clinical data analyst. I also work casually as an after-hours manager on weekends. I am the secretary of the Blood Transfusion Committee at the Mater Hospital Sydney and through numerous audits I developed an interest in blood and transfusion practice. Hence, the inception of my project titled 'Implementation of a Patient Blood Management Program in a private orthopaedic unit: A pilot study'. Simply put, my experience at NRI has been great. I've learned a lot about the complex nature of ethics submissions, but it has been worthwhile in the end. I have been mentored to prepare a paper for publication. The NRI experience has given me great insight into the rigors of research. I would definitely like to do more research, perhaps a PhD or continue with various projects for publication.

I am the Quality Manager Accreditation for St Vincent's Private Hospital Sydney (SVPHS). As a Magnet designated hospital, SVPHS is active in both research and clinical education, and many of our clinicians are actively involved with the research institutes with which the Hospital partners. I have a strong history of collaboration with Associate Professor Elizabeth McInnes and have partnered with the NRI on a number of projects, mainly focused on pressure injury prevention. One of the things I have enjoyed about my collaboration with the NRI is that it has allowed me to broaden my knowledge of research and combine it with my clinical expertise in skin integrity.

For each study that I have been involved with I have been part of each study's investigatory team. Through these opportunities I have also had hand-on experience collecting data and recruiting study participants, and been an author on two peer-reviewed papers. Recently I have been an Associate Investigator on an NHMRC research project focused on pressure injury prevention. This has given me insights into the conduct and logistics of a multi-site, multi-state cluster randomised controlled trial. Armed with this research knowledge, I have now embarked on a PhD investigating 'What are best practice clinical governance principles for safety & quality in acute healthcare facilities?'

The International Stroke Research Collaboration (ISReC) is a research initiative in the area of stroke funded by the Australian Catholic University (ACU) Research Program. ISReC commenced in January 2015 with the employment of two dedicated Research Fellows, Dr Louise Craig and Dr Verena Schadewaldt. Importantly, the Collaboration builds on our existing strong research partnership with stroke researchers from the United States of America (USA), namely, Professor Anne Alexandrov; Professor Caroline Watkins from the United Kingdom (UK); and Associate Professor Dominique Cadilhac from Monash University and the Florey Institute of Neuroscience and Mental Health, University of Melbourne. We also congratulate and welcome Dr Elizabeth Lightbody (UK) who was this year awarded an ACU Clinical Fellow title for her collaboration with ISReC. ISReC aims to undertake internationally significant stroke research with high clinical relevance and impact, whilst developing ACU's stroke research capacity. One of our first projects is examining variation in administration practices for intravenous thrombolysis in acute ischaemic stroke patients in the USA, UK and Australia.

European Stroke Conference 2015

The Nursing Research Institute's (NRI) Director, Professor Sandy Middleton, was delighted to be invited as key speaker at the European Stroke Organisation in Glasgow on 17th -19th April 2015. She presented a session on 'Preventing complications: Promoting recovery and preventing complications' to an international audience of up to 150 health delegates. Ms Simeon Dale also presented a poster on our successful Quality in Acute Stroke Implementation Project (QASCIP). The NRI partnered with the NSW Agency for Clinical Innovation, 15 NSW Local Health Districts (LHD), academics, clinicians, and the National Stroke Foundation to establish a translational quality improvement project to improve management of fever, hyperglycaemia,

and swallowing processes of care across the state. The main aim of the project was to implement evidence from the original QASC trial into all 36 NSW stroke services and to rigorously evaluate the process. The project involved over 2000 patients from 36 stroke services. Professor Middleton and her team successfully changed clinician behaviour for fever, hyperglycaemia, and swallowing management in only 14 months for which they were awarded the NSW Premier's Public Sector Award for Improving Performance and Accountability.



INTroducing A Care bundle To prevent pressure injury (INTACT) recruitment success

In May, a morning tea was held to celebrate the successful recruitment of 200 patients at St Vincent's Private Hospital Sydney for the INTroducing A Care bundle To prevent pressure injury (INTACT) trial. Ms Rosemary Phillips (left), Site Coordinator, and Ms Lisa Davey (right), Recruitment Officer, were congratulated for their hard work and recruitment achievements.

INTACT is a nursing led, NHMRC funded, multi-site cluster randomised controlled trial of a novel intervention that incorporates several pressure injury prevention strategies into a care bundle which focuses on patient participation. The aim of

the INTACT trial was to test whether providing patients with a formal education strategy reduce the development of pressure injuries in 'at risk' hospitalised patients. The study was led by Griffith University with St Vincent's Hospital Sydney and St Vincent's Private Hospital Sydney being the only participating hospitals in NSW.

Hospital acquired pressure injuries are a serious and ongoing concern for health services worldwide. Surgical patients are considered to be of high risk of developing pressure injuries due to immobility caused by anaesthesia and length of surgery. However, there is little extant research, particularly in Australia, that has measured pressure injury incidence in this group of patients. In 2015, the NRI sought to address this research and clinical knowledge gap and commenced a prospective cohort study at St Vincent's Hospital Sydney. The SPPII study aims were to investigate the incidence of post-surgical pressure injuries among elective surgical patients with a minimum hospital stay of 48 hours and identify potentially controllable extrinsic risk factors that may be associated with developing pressure injuries. Patient recruitment has now been completed and results will be available in 2017.

Media Interview - Hospital Managers Can Help Drive Hand Hygiene Compliance



The NRIs Deputy Director, Associate Professor Elizabeth McInnes was interviewed by Infection Control Today about a published qualitative study on senior hospital managers' views on current and innovative strategies to improve hand hygiene. The report notes that the NRI's study adds to the ongoing debate as to whether there should be a shift in focus from a systematic failure to personal accountability, in order to strengthen hand hygiene compliance programs. Associate Professor McInnes reiterated the importance of the requirements of a top down approach to culture change — whether developing new or revamping old policies, or taking disciplinary measures for failure to comply. It was noted that senior leaders should directly engage with frontline managers, supervisors, and staff and secure their commitment to embed the message that best practice hand hygiene is part of the organisational mantra and the way we do things around here. The significance of the article, on which this interview was based, is also demonstrated by its inclusion in the Australian Commission on Safety and Quality in Health Care's 'On the Radar' ePublication. 


