Message from the Directors

The NRI has achieved another successful year with a new professorial appointment and funded projects and collaborations. In this report we showcase some of the highlights.

This year, the NRI's Deputy Director, Professor Elizabeth McInnes, was appointed as the Professor of Nursing at St Vincent's Hospital Melbourne (SVHM). Professor McInnes commenced her role in May 2019 and is working closely with Clinical Associate Professor Kathryn Riddell, Chief Nursing Officer SVHM, to provide leadership in nurse-led multidisciplinary health research. Excitingly, this collaboration will also provide opportunities for the NRI to conduct translational research at both St Vincent's Health Australia Sydney (SVHAS) and SVHM. The NRI research team now consists of 18 research and administrative staff located in New South Wales and Victoria.

Additional highlights include:

- Vice-Chancellor's Staff Excellence Award (Excellence in Research and Research Partnerships) for the Quality in Acute Stroke Care (QASC) 10-year research program.
- A score of 'high' on the Australian Research Council's inaugural Engagement and Impact exercise for outcomes arising from the National Health and Medical Research Council funded Quality in Acute Stroke Care trial.
- The inaugural Nursing Research Symposium held at St Vincent's Hospital Melbourne.
- The appointment of Ms Lauren Christie as the inaugural Allied Health Senior Research Fellow, Implementation Science Research, a joint position between the NRI and SVHAS to support allied health research.








Figure 1: NRI grant funds awarded: 2009–2019




Figure 2: Number of NRI peer-reviewed publications, 2009–2019




