



ACU Sport Facilities – Terms of Use CANBERRA POOL

The following terms apply to all ACU sport facilities. By accessing these facilities, you agree to the terms stated below.

Defying these terms may result in being required to leave the venue.

Use of Facilities: All persons making use of these ACU sport facilities must:

- a) Use the sport facilities only for their intended purpose, or as directed by ACU.
- b) Leave the sport facility in the same condition as it was when it was accessed.
- c) Running, pushing, flips and bombing is not permitted.
- d) Diving is only permitted where the depth of the pool indicates greater than 1.2m.
- e) Not climb on fences, backboards, backstops or buildings.

Patrons must follow any reasonable instructions given by the ACU Lifeguards and pool staff

Advertising: All signage is to be approved by ACU prior to being displayed at venue. ACU reserves the right to remove any non-compliant signage without notice.

Alcohol, smoking and drug use: Alcohol, drugs and tobacco are not permitted in the pool or in the areas surrounding the pool facility, including change rooms, spectator viewing areas or along the pool deck. Event permits that include alcohol are at the discretion of ACU. Under no circumstance is glass or porcelain permitted within the sport facility.

Children: All children under 15 years of age must be accompanied and supervised by a parent or guardian (aged 18 years or older) at all times.

Animals: Animals are not permitted at any sport facilities with the exception of Guide/Assist dogs or otherwise as permitted by law.

Behaviour: Un-sportsman like behaviour, swearing and bad language by class participants, players, coaching staff or spectators is not welcome or tolerated in the pool, pool deck or other spectator areas. Offensive or inappropriate behaviour will result in immediate eviction from the facility. CCTV is in operation 24/7.

Coaching: Coaching or training must not be conducted for fee or reward without prior permission of ACU.

Filming: The use of cameras, drones, audio or video recorders and other recording devices within the sport facility is strictly prohibited unless express written permission has been granted by ACU.

Fire Prevention: No naked flames or fireworks should be brought onto the pool area. No person shall kindle or maintain an outdoor cooking fire. Gas/electric BBQs may only be used after express written permission has been granted by ACU.

Swimming Attire: Appropriate swimwear is required to be worn at all times whilst swimming.

Inclement Weather: ACU reserves the right to close the sport facility due to severe weather forecast or current conditions.

Litter: All rubbish must be removed from the sport facility after each use.

Lost Property: All lost property items should be left with ACU security. You agree that you are solely responsible for the security of your property at the facility and ACU is not responsible for any loss or damage including any theft. ACU is not liable for any damage to your property under any circumstances.

Sound and Electronics: No amplified sound is permitted in ACU campus facilities without the express written prior consent of ACU. All portable electronic equipment and appliances must undergo tag and testing before use at any venue.

Structures: All marquees and structures must be anchored using weights.

- a) Pegs, spokes or any sharp objects are not permitted in the pool area unless prior permission has been granted by ACU.
- b) All structures over 3x3m require insurance, verified by a Certificate of Currency and engineer sign off and engineer certified installation.

The following terms apply to all ACU sport facilities. By accessing these facilities, you agree to the terms stated below.

Defying these terms may result in being required to leave the venue.

Use of Facilities: All persons making use of these ACU sport facilities must:

- a) Use the sport facilities only for their intended purpose, or as directed by ACU.
- b) Leave the sport facility in the same condition as it was when it was accessed.
- c) Not climb on fences, backboards, backstops or buildings.

Advertising: All signage is to be approved by ACU prior to being displayed at venue. ACU reserves the right to remove any non-compliant signage without notice.

Alcohol, smoking and drug use: Alcohol, drugs and tobacco are not permitted on field of play or in the areas surrounding the sport facility, including change rooms, spectator viewing areas or along the sidelines. Event permits that include alcohol are at the discretion of ACU. Under no circumstance is glass permitted within the sport facility.

Children: All children under 15 years of age must be accompanied and supervised by a parent or guardian (aged 18 years or older) at all times.

Animals: Animals are not permitted at any sport facilities with the exception of Guide/Assist dogs or otherwise as permitted by law.

Behaviour: Un-sportsman like behaviour, swearing and bad language by players, coaching staff or spectators is not welcome or tolerated on the field of play, sidelines or spectator areas. Offensive or inappropriate behaviour will result in immediate eviction from the facility. CCTV is in operation 24/7.

Filming: The use of cameras, drones, audio or video recorders and other recording devices within the sport facility is strictly prohibited unless express written permission has been granted by ACU. Federal Aviation approval for Drone use is required prior to a request to ACU.

Fire Prevention: No naked flames or fireworks should be brought onto the field of play. No person shall kindle or maintain an outdoor cooking fire. Gas/electric BBQs may only be used after express written permission has been granted by ACU.

Footwear: Appropriate footwear is required to be worn at all times on playing surface. Correct footwear includes closed in runners/sneakers.

Inclement Weather: ACU reserves the right to close the sport facility due to forecast or current inclement weather.

Litter: All rubbish must be removed from the sport facility after each use.

Lost Property: All lost property items should be left with ACU security. You agree that you are solely responsible for the security of your property at the facility and ACU is not responsible for any loss or damage including any theft. ACU is not liable for any damage to your property under any circumstances.

Sound and Electronics: No amplified sound is permitted in ACU campus facilities without the express written prior consent of ACU. All portable electronic equipment and appliances must undergo tag and testing before use at any venue.
